The Queen Creek County Island Fire District (QCCIFD) administrator and governing board met in a properly posted open public meeting on Wednesday, January 17, 2018. - B. Roll Call: Chair Memmott, Clerk Ruscetti and Members Kuefner and Woodruff in attendance.

Item 1: Consideration of approval of the governing board meeting minutes of November 15, 2017 (QCCIFD #18-001):

Motion by Ruscetti / 2^{nd} by Memmott: To approve the November 15, 2017 minutes as presented; Passed 4-0.

Item 3: Report from the fire chief regarding the provision of fire and EMS to the QCCIFD, including but not limited to the following items (QCCIFD #18-n/a):

a) Monthly response and service report: Chief Gray discussed the November and December 2017 response reports and answered general questions from the board on information provided in the reports. Chief Gray discussed that there was an 11% increase in call volume in 2017. They are running more calls as the town grows.

Item 5: Consideration of renewing the district's general liability and associated insurance coverage with VFIS of Arizona (QCCIFD #18-004).

Administrative Manager Vaughn provided an overview of the insurance services proposal by VFIS that had been distributed to each board member. The annual premium came in at \$35,047. The fire district had budgeted \$34,500. There was a general discussion by the board concerning various components within the VFIS insurance proposal. Vaughn answered general questions from the board regarding the proposal.

Motion by Memmott / 2nd by Woodruff: To approve renewing the district's general liability and associated insurance and policies with VFIS of Arizona; Passed 4-0.

Item 6: Consideration of QCCIFD website rebuild (QCCIFD #18-005):

The board discussed the need to improve and update the current QCCIFD website. Members will look into getting quotes to discuss at next board meeting.
