Notice is hereby given to the general public that the Queen Creek County Island Fire District (QCCIFD) governing board will hold a meeting on Wednesday, May 31, 2023. The meeting will be held at the Town of Queen Creek Municipal Services Building - San Tan Conference Room, located at 22358 S. Ellsworth Road, Queen Creek, Arizona. The meeting will be open to the general public and will begin at 6:30 p.m. local time.

The following agenda items are scheduled for consideration at the board meeting. Action or decisions may or may not be taken on any or all items. Agenda items may or may not be considered in the order listed:

A public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.
3. Report from the fire chief regarding the provision of fire and EMS to the QCCIFD, including but not limited to the following items (QCCIFD #23-n/a):
 - a) Monthly response and service reports.
4. Consideration of district financial matters:
 - a) Review of monthly financial reports: March and April (QCCIFD #23-021).
 - b) Review of invoices / payables and authorization for payment (QCCIFD #23-022).

Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2023 and ending June 30, 2024 pursuant to A.R.S. §48-853; declaring such for publishing and public notice; and setting July 19, 2023 at 6:30 p.m. local time for a public hearing prior to adoption (QCCIFD #23-024).
7. Consideration of items for the agenda of the Queen Creek County Island Fire District's next regular scheduled meeting (July 19, 2023) and or a special meeting called by the governing board for the purpose of carrying out its powers and duties (QCCIFD #23-025).
