The meeting will be open to the general public and will begin at 6:30 p.m. local time.

*A public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.*

Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2024 and ending June 30, 2025 pursuant to A.R.S. §48-853; declaring such for publishing and public notice; and setting July 24, 2024 at 6:30 p.m. local time for a public hearing prior to adoption (QCCIFD #24-020).

Consideration of noticing the Maricopa County Board of Supervisors and the Maricopa County Elections Department the district will call for an election of board members on November 5, 2024 pursuant to ARS §48-852 and ARS §16-226.A; will use the Maricopa County Elections Department to conduct the election; and to direct staff to facilitate compliance with ARS §16-227, ARS §16-228 and ARS §16-229 as required for the election of district board members (QCCIFD #24-021).
